**SUBJECT:** 2024 Legislative Session Summary

The 2024 Legislative Session came to a close on Friday, March 8, as the Florida Legislature adjourned *Sine Die* at 2:25 p.m. The only Constitutional requirement of the Legislature is to pass the budget, which they did timely for the second consecutive year. The final agreed upon budget of \$117.5 billion represents the largest in state history topping last year's record-setting budget of \$116.5 billion. The Legislature also passed 325 bills compared to just 285 in 2023.

### **KEY ISSUES**

### **Acceptance of Cash Payments by Businesses**

<u>HB 35</u> by Representative Joel Rudman (R-Navarre) would have required certain businesses to accept cash payments for certain transactions; prohibited fees or conditions for such transactions; provided applicability & civil penalties; required DACS to adopt rules. The House bill did not receive a committee hearing. The Senate companion – <u>SB 106</u> – by Senator Shevrin Jones (D-Miami Gardens) was temporarily postponed during the Senate Fiscal Policy Committee on February 27 and not reconsidered.

On January 17, Liberty Partners of Tallahassee Director of Client Relations Ethan Merchant testified before the Senate Agriculture, Environment, and General Government Appropriations Committee on behalf of FAA in opposition to SB 106. In his remarks, Ethan highlighted that 39% of FAA's members are either "cashless" or "partially cashless" and that this bill would create a new operating expense on attractions – many of which revised their payment system operations during the COVID-19 pandemic.

On January 18, Liberty Partners of Tallahassee President Jennifer Green and Director of Client Relations met with both bill sponsors. During these meetings, Liberty Partners discussed FAA's position on the bills

and laid out our concerns with the bills. We also discussed possible alternative solutions to address the issues that each lawmaker is trying to solve.

Ahead of SB 106 being considered in the Senate Fiscal Policy Committee – although it was ultimately temporarily postponed – Liberty Partners distributed letters on behalf of FAA to each member of the committee. In the letters, we listed FAA's concern with the legislation and the effect it would have on small and medium sized attractions that cannot afford a "cash-to-card" kiosk.

While we are grateful that the legislation was not passed during the 2024 Legislative Session, we expect the issue to arise again during the 2025 Legislative Session. We look forward to working with Senator Jones, Representative Rudman, staff and the appropriate state agencies over the summer to address concerns with this issue and find a solution to the issue the legislators are seeking to fix.

## **Tourist Development Tax**

Several bills related to tourist development tax (TDT) were filed during the 2024 Legislative Session. The original version of the House tax package – HB 7073 – contained a number of harmful provisions, which were later removed. The initial provisions would have sunset existing TDTs unless the TDT was renewed by a voter referendum in that County before July 2029, and would have required a voter referendum for a new TDT, which would limit all new TDT to six years and require voter referendums in the County to renew. Additionally, the bill would have allowed certain counties designated as an Area of Critical State Concern that levy a TDT and a tourist impact tax to use surplus tourism revenue to provide affordable housing. Since HB 7073 was filed, Liberty Partners of Tallahassee has urged the House to reconsider these changes to TDT and expressed FAA's longstanding policy that TDT should be used for their intended marketing purposes.

HB 1599 by Representative Keith Truenow (R-Tavares) would have prohibited the allocation of more than 25% of TDT revenue from an individual project without a supermajority vote by the governing board of the county. The bill never received a hearing in the House Ways and Means Committee. The Senate companion – SB 1748 – by Senator Jason Brodeur (R-Lake Mary) did not receive a final hearing in the Senate Appropriations Committee.

<u>HB 1081</u> by Representative Juan Porras (R-Miami) would have required certain counties to use revenue received from tourist development tax in a specified manner; required that charter county convention development moneys be distributed to certain entities for specified purposes; deleted a specified notification requirement. The bill never received a second hearing in the House Ways and Means Committee. The Senate companion – <u>SB 1072</u> – by Senator Bryan Avila (R-Miami Gardens) never received a second hearing in the Senate Finance and Tax Committee.

SB 1456 by Senator Ana Maria Rodriguez (R-Doral) passed the Legislature on March 5. This legislation imposes new housing and hurricane evacuation requirements for specifically the Florida Keys or the City of Key West Areas of Critical State Concern. The legislation will also allow Monroe County to use surplus TDT and tourist impact tax funds to create affordable housing for private sector tourism-related employees, with the affordable status being maintained for no less than 99 years.

### VISIT FLORIDA

We are pleased to report that the Legislature has allocated \$80 million for VISIT FLORIDA tourism marketing during FY 2024-25. This is the same level of funding that VISIT FLORIDA received in FY 2023-24, but less than the \$105 million that was included in Governor Ron DeSantis' budget recommendations.

### **Cultural and Historical Programs**

A significant amount of money is allocated in the state's FY 2024-25 budget for cultural and historical programs. The budget contains \$60.8 million for Cultural and Museum Program Support Grants and Initiatives, \$50.6 million for Historical Preservation Grants and Initiatives, and \$4.7 million for African American Cultural and Historic Grants.

### **FULL SUMMARY**

Governor Ron DeSantis, House Speaker Paul Renner and Senate President Kathleen Passidomo each secured several victories this Legislative Session as many of their policy priorities were passed by the Legislature.

A major win for Speaker Renner during the Session was passing legislation, **HB 1**, intended to nurture and preserve the mental health of Florida's children from the harmful effects of social media. During Speaker Renner's opening day remarks, he stressed the negative impact on children's mental health and well-being that social media has on Florida's children. The bill proposed would require social media companies to prohibit minors under the age of 16 from accessing these platforms. The Legislature shared Speaker Renner's sentiment by passing **HB 1** on February 22, 2024 only for it to be vetoed by the Governor on March 1, 2024, indicating his desire for the Florida Legislature to produce a more superior bill that would protect children from the harms associated with social media while also preserving parents' rights and maintaining the ability of adults to engage in anonymous speech.

The revised social media language from **HB 1** was eventually incorporated into **HB 3**, which was designed to protect children under the age of 18 from harmful online content, such as pornography, by requiring age verification by websites and applications that publish material harmful to minors. The bill also requires that all data collected to verify the age of a person attempting to obtain access to harmful material be deleted immediately. This bill, containing many of the same provisions originally in **HB 1**, was passed by the Legislature on March 6, 2024, and will now head to the Governor's desk for approval.

President Passidomo also secured some major wins during the 2024 Legislative Session. One of the President's main priorities this Session was to increase access to healthcare. As a result, the Legislature passed the "Live Healthy Act" - SB 7016. Several other bills designed to increase workforce mobility and offer incentives to work in needed fields such as mental health, labor, and disability were passed including SB 1600, SB 330, SB 7018, SB 1758, and HB 7089. These bills also increase access to healthcare in rural and underserved communities by investing in the availability of healthcare technology and expanding clinical training sites in these areas as well as providing for an ease of licensure for individuals coming in to Florida from other states.

Another goal of President Passidomo was to remove the red tape in public schools while still maintaining high academic standards. The Legislature passed the "Learn Local Act" to support this goal. **SB 7000** and **SB 7002** attempt to address the teacher shortage by expanding and changing some of the channels to acquire and maintain a teacher certification by increasing flexibility of district school boards in hiring and giving raises to teachers. The bills also make significant changes to student assessments by giving parents more of a voice in their children's education.

Governor DeSantis saw several of his priorities related to insurance premiums and toll relief cross the finish line this Session. The Legislature's tax package - **HB 7073** - for FY 2024-25 includes a one-year relief for residential property insurance policyholders, covering the cost of insurance premium tax and the State Fire Marshal assessment for residential property insurance policies written between October 1, 2024, and September 30, 2025 for a twelve-month coverage period. It also includes a one-year insurance premium tax relief on flood insurance policies for policies written between October 1, 2024 and September 30, 2025. As for toll relief, the Legislature's tax package includes toll relief for certain high-use customers from April 2024 until March 2025.

As expected, the 2024 Legislative Session was not complete without the passage of a balanced budget for FY 2024-25. Governor DeSantis had provided his budget recommendations in December 2023 to the tune of \$114.4 billion - which was \$4.5 billion less than the current state budget. After a lengthy joint budget conference, leaders of the House and Senate Appropriations Subcommittees highlighted their respective budget areas in the \$117.5 billion state spending plan. On the last day of the Legislative Session, the House and Senate passed HB 5001 as the General Appropriations Act and all associated budget bills. Once he receives it, Governor Ron DeSantis will have 15 days to prepare his veto pen and then sign the budget into law. With the Governor's line-item veto authority it is anticipated the final state budget is to be significantly less than the Legislature's final product.

# Highlights of the FY 2024-25 budget include:

- \$10 billion in total reserves
- 3-percent pay increase for all state employees
- \$28.4 billion in funding for K-12 FEFP Public Schools
- \$717.1 million for the "Live Healthy" program, including an increase of \$245.7 million for Medicaid Providers
- \$100 million in correctional facilities capital improvement
- \$17 million for law enforcement recruitment bonus program
- \$75 million for the Florida Job Growth Grant Fund

- \$80 million for VISIT FLORIDA
- \$100 million for broadband equity access and deployment
- \$1.02 billion of funding to communities with open Federally declared disasters
- \$100 million for the Rural and Family Lands Protection Program
- \$135 million for the Wastewater Grant Program
- \$178.3 million for water infrastructure improvements

The Legislature also passed their annual tax package in **HB 7073**. This year's tax package includes a \$5 million credit for three years against the corporate income tax for businesses employing persons with unique abilities of \$1,000 per employee. Additionally, the bill provides for a \$5 million credit for three years for businesses for childcare expenses incurred on behalf of employees and increases the annual cap for the Strong Families Tax Credit Program from \$20 million to \$40 million. **HB 7073** also includes the following four sales tax holidays:

Back to School Sales Tax Holiday - July 29 - August 11, 2024 Freedom Summer Sales Tax Holiday - July 1 - July 31, 2024 Tool-Time Sales Tax Holiday- September 1 - September 7, 2024 Disaster Preparedness Sales Tax Holidays - June 1 - June 14, 2024 and August 24 - September 6, 2024

### **KEY BILLS THAT PASSED**

### **Online Protections for Minors**

**HB 1** by Rep. Tyler Sirois (R-Merritt Island) requires social media platforms to terminate accounts of minors under the age of 16 and prohibit them from creating new ones. They must also implement reasonable age verification methods to verify the ages of account holders. The bill allows minors aged 16 or 17 to create an account but the social media company must include links to help services, such as local resources for law enforcement, suicide prevention, and domestic abuse prevention services. The bill passed the House and Senate before being vetoed by Gov. Ron DeSantis. The decision to veto ultimately came down to supporting the rights of parents. Gov. DeSantis stated in his veto letter that **HB 3** will make a change that protects children while still supporting parents' rights, which he would gladly support.

### **Online Access to Materials Harmful to Minors**

**HB 3** by Rep. Chase Tramont (R-Port Orange) is a very similar bill to **HB 1**. The bill requires social media companies to use reasonable age verification through a third party, allow 16- and 17-year-olds to create a social media account, and provide resources to local law enforcement, suicide prevention, domestic abuse prevention, and other helpful links. The bill differs from **HB 1** by giving parents a voice in their children's social media usage. The bill allows minors aged 14 and 15 to create a social media account with the consent of a parent. Federal law sets the minimum age for social media accounts at 13 years old. This bill will set Florida's one year higher with parental consent.

### **Live Healthy Act**

The "Live Healthy Act" was a main priority for President Passidomo and is composed of two bills. The bills are **SB 7016** by Sen. Colleen Burton (R-Lakeland) and **SB 7018** by Sen. Gayle Harrell (R-Stuart). The "Live Healthy Act" helps expand healthcare access into rural and difficult-to-access communities by expanding sites for more clinical training. The legislation also increases access to preventative health screenings to ensure early diagnosis and better management of chronic disease. It also streamlines emergency departments through partnerships with Community Health Centers so care that is urgently needed, but not life-threatening, can be handled outside of the hospital emergency room in a more efficient and cost-effective setting. "Live Healthy" also is attempting to tackle the shortage of healthcare workers throughout the state. The bill does this by increasing workforce mobility and by offering incentives for healthcare workers to work in needed fields such as labor and delivery, mental health, and disabilities. It also provides \$50 million in funding to increase the number of GME residency slots to help retain physicians from Florida schools. Another way the bills help rural and underserved communities is through targeted investments to help them integrate the latest healthcare technology.

### Learn Local Act

The "Learn Local Act" was another priority of President Passidomo and consisted of three bills. The bills are **SB 7000** by Sen. Alexis Calatayud (R-Miami), **SB 7002** by Sen. Travis Hutson (R-St. Augustine), and **SB 7004** by Sen. Corey Simon (R-Quincy). The legislation is designed to reduce excessive regulations on public schools, empower parents, teachers, and local school districts, and preserve strong accountability, transparency, and safety measures at neighborhood public schools. The trio of bills also allow parents more of a voice in their children's education.

### **School Choice**

HB 1403 by Rep. Josie Tomkow (R-Auburndale) establishes firm deadlines for Scholarship Funding Organizations (SFO) and parents related to the application and renewal of the Florida Tax Credit (FTC), PEP, FES-UA, and FES-EO scholarship programs. The deadlines prioritize disbursing scholarship funds to renewal students before new students. The bill authorizes FTC funds to be used for full-time private school scholarships year-round.

### **Unauthorized Public Camping and Public Sleeping**

HB 1365 by Rep. Sam Garrison (R-Fleming Island) prohibits a county or municipality from allowing any person to regularly sleep or camp on public property unless the area has that designation. In order to get an area designated for public sleeping, the county's governing body must support it by a majority vote and the Department of Children and Families must certify that it meets certain requirements. The minimum requirements are related to ensuring safety, security, sanitation, mental health and substance abuse services coordination, and illegal substance and alcohol use prohibition. The bill also authorizes the Department of Children and Families to inspect designated areas at any time and recommend closure if the minimum requirements are not being met. Finally, the bill establishes a civil cause of action that allows a resident of a county, a business owner in the county, or the Attorney General to bring a civil action against a county or municipality for authorizing public camping or sleeping in an area not designated for such purpose.

### **Employment Regulations**

HB 433 by the House Commerce Committee would prohibit local governments from preferring one contractor over another based on the wages or employment benefits provided by the contractor. The bill would also remove the ability of local governments to require a minimum wage for certain employees under the terms of a contract, would preempt the regulation of the terms of employment to the state, and allow local governments to provide certain employment benefits for the employees of the local government that exceed state or federal law.

### **Employment and Curfew of Minors**

**HB 49** by Rep. Linda Chaney (R-St. Petersburg) would have removed restrictions around employing minors aged 16 or 17. The bill would have allowed minors aged 16 or 17 to work up to 40 hours a week. These minors would have to be granted breaks and safe working conditions as a person 18 years or older. The bill would not have allowed minors aged 16 or 17 to work before 6:00 am or after 11:00 pm when school is scheduled the following day and would not have applied to minors who have earned their high school diploma.

## **Economic Development**

HB 141 by Rep. Shane Abbott (R-DeFuniak Springs) eliminates several requirements related to the Regional Rural Development Grants Program. The bill would remove the requirements for grant funds received by a regional development organization to be matched each year by nonstate resources in an amount equal to 25-percent of the state contributions. It would also remove the requirement for local governments and private businesses to make financial or in-kind commitments to the regional organization as well as the requirement that the DOC consider the demonstrated need of the applicant for assistance when approving participants for the program. The bill received unanimous support in both chambers.

### **Funding for Environmental Resource Management**

**SB 1638** by Sen. Travis Hutson (R-Palm Coast) requires that 96-percent of the revenues from the 2021 gaming compact between the Seminole Tribe of Florida and the State of Florida for the acquisition and management of conservation lands and the identification and prioritization of critical clean water infrastructure investments be deposited in the Indian Gaming Revenue Trust Fund. The funds will be distributed as follows:

- \$100 million to support the wildlife corridor.
- \$100 million for the management of uplands and the removal of invasive species.
- \$100 million to the DEP to the Resilient Florida Trust Fund.

### **Interstate Mobility**

**SB 1600** by Sen. Jay Collins (R-Tampa) requires the regulatory boards in the Department of Professional Regulation (DBPR), when endorsement based on years of licensure is not otherwise provided by law in the practice act for a profession, to allow licensure by endorsement for any individual who applies for licensure by endorsement if the applicant meets certain specified criteria. The bill excludes harbor pilots. The bill also requires the Department of Health (DOH) to issue a license by endorsement to a qualified

applicant within seven days of receipt of all required documents for specified healthcare professions regulated by the DOH when the applicant meets specific criteria.

### **Vacation Rentals**

**SB 280** by Sen. Nick DiCeglie (R-St. Petersburg) preempts the regulation of advertising platforms to the state. As for the properties themselves, the bill allows a local government to require vacation rentals to be registered. The bill allows local governments to charge a reasonable registration fee and to inspect a vacation rental after registration to verify compliance with the Florida Building Code and the Florida Fire Prevention Code. The bill establishes limits for a local government registration program, including requiring a vacation rental owner to provide proof of state licensure, submit identifying information, obtain any required tax registrations, and pay all recorded municipal or county code liens. Finally, the bill permits "grandfathered" local laws, ordinances, or regulations to be amended to be less restrictive or to comply with local registration requirements.

### **KEY BILLS THAT FAILED**

### **Suits Against the Government**

**SB 472** by Sen. Jason Brodeur (R-Lake Mary) would have increased the cap on the payment of judgments against government entities from \$200,000 to \$400,000 per individual, and from \$300,000 to \$600,000 per instance without a claims bill. The bill would also have allowed local governments to settle claims of any amount without the need for legislative approval. It would also have enabled state agencies to pay amounts exceeding sovereign immunity waivers and insurance coverage through legislative claim bills. Lastly, the bill would have eliminated home venue privilege, meaning claimants would have more flexibility in choosing the lawsuit location.

### **Government Accountability**

HB 735 by Rep. Alex Andrade (R-Pensacola) would have prohibited state and local officials from soliciting or accepting anything of value from a foreign country of concern. It would have also centralized lobbyist registration for local governments with the State Commission on Ethics. Finally, the bill would have required that contracts for certain local government employees would not be renegotiated or extended within eight months of a general election for the governing body.

### **County Commissioner Term Limits**

**HB 57** by Rep. Michelle Salzman (R-Cantonment) would have limited county commissioners to serve for a maximum of eight consecutive years. The bill would have excluded counties with charter provisions that conflict with its limits. A commissioner who termed out would have had to must sit for two years before running for a different district seat or at-large seat of the county commission.

### **Municipal Utilities**

**HB 1277** by Rep. Demi Busatta Cabrera (R-Coral Gables) and **SB 104** by Sen. Shevrin Jones (D-Miami) would have authorized a municipality to fund or finance general government functions with a portion of revenues from utility operations, establish limits on utility revenue transfers for municipal utilities, modify

provisions relating to permissible rates, fees, & charges imposed by municipal water & sewer utilities on customers located outside municipal boundaries.

### **CONSTITUTIONAL AMENDMENTS**

In addition to two citizen-initiative proposed Constitutional amendments dealing with adult personal use of marijuana and limiting government interference in abortion, the Florida Legislature approved two more proposed constitutional amendments for placement on the November 2024 general election ballot:

**HJR 7017** - Annual Adjustment to Homestead Exemption Value **SJR 1114** - Public Financing for Campaigns of Candidates for Elective Statewide Office

Also on the November 2024 ballot are two proposed Constitutional amendments that the Legislature passed during the 2023 Legislative Session related to the right to fish and hunt and district school board partisan elections. All six of these proposed Constitutional amendments require a 60% approval by Florida voters.
